CIRCULAR

Children Education Allowance for children of the employees for the period w.e.f 01.04.2018 to 31.03.2019 is considered for release. CEA is admissible only if the Schools/ Colleges where the children are studying are recognized as per CEA rule. Eligible employees are requested to submit their claim (as per Performa enclosed) on or before 20th March 2019 positively.

A. The annual ceiling fixed for reimbursement of Children Education Allowance is Rs. 27000/-per child.

For claiming reimbursement of CEA, a certificate from the head of institution, where the ward of government employee studies, will be sufficient for this purpose. The certificate should confirm that the child studied in the school during the previous academic year. In order to claim reimbursement of CEA, the Govt. servant should produce a certificate issued by the Head of the Institution for the period/year for which claim has been preferred. The certificate should confirm that the child studied in the school during the previous academic year. In case such certificate cannot be obtained, self-attested copy of the report card or self attested fee receipt(s){including e-receipt(s)} confirming/indicating that the fee deposited for the entire academic year can be produced as a supporting document to claim CEA. The period/year means academic year i.e. twelve months of complete academic session.

B. The Hostel subsidy shall be Rs. 6750/- per month per child.

For Hostel Subsidy, a similar certificate from the head of institution will suffice with the additional requirement that the certificate should mention the amount of expenditure incurred by the government servant towards lodging and boarding in the residential complex. The amount of expenditure mentioned, or the ceiling as mentioned above, whichever is lower, shall be paid to the employee

- 1. Children Education Allowance is admissible for the two eldest surviving children only (from Nursery to Class XII).
- 2. The children must be in the age limit of upto 20 years (22 years in case of Physically/ mentally handicapped children).
- 3. The rates of Special Allowance for child care to women with disabilities stands revised to Rs. 3000/- per month.
- 4. Children with disabilities, reimbursement will be at double the rates and the annual ceiling will be Rs. 54000/- per annum per child and the rates of Hostel Subsidy for disabled children of Government employees shall be treated as revised to Rs. 13500/- per child per month.
- 5. Further, additional claim can also be made against the financial year 2017-18 proportionately against 9(nine) months according to the revision of allowances as per recommendation of 7th CPC.
